The Interested bidders may submit their on-line bids along with separate Demand Drafts drawn in favour of "Director, Centre for Electronic Governance, Jaipur" payable at Jaipur towards the cost of Tender Fee (non-refundable) and RISL Processing Fee (Non-refundable) demand draft shall be in favour of "Managing Director, RISL" payable at Jaipur.
3. The above mentioned demand drafts and the Bid Security declaration must reach physically in the office of Procurement Entity, Centre for Electronic Governance, Jaipur on or before last date & time as mentioned above failing which bids shall not be considered.
4. Bidders, having digital signature certificate (DSC) as per IT Act, 2000 to sign their electronic Bids, shall submit their offer online on www.eproc.rajasthan.gov.in within stipulated time and date mentioned herein above. Bids shall not be accepted personally. The Bids will be opened on the same date and time before purchase committee in the presence of bidder or their authorized representative whosoever may be present.
5. In the event of the specified dates being a holiday, the activities assigned on that date may be carried out on next working day on the same time.
6. Bids received after the prescribed time and date will not be considered.
7. The bidders shall have to submit GST Registration number along with copy of the Registration Certificate.
